Course Description	This course provides a broad overview of the nature of inquiry in political science and is intended to give students an understanding of how to do empirical research. Students will finish the course knowing how philosophy of science, research design, and statistical and causal inference are understood in the discipline of political science. To be taken during semester before POL 498/9. *This course satisfies the Information Literacy requirement of General Education.	
Learning Outcomes	This course is designed to help you learn how to perform rigorous political science research, utilizing a variety of methods, in preparation for the writing of your final thesis in POL 498/9 or completing an advanced fieldwork project in POL 480. You may even begin work on your final thesis/fieldwork project in this class, if you already have an idea of what you'd like to do. The course learning outcomes are for you to: 1. Explain social science research processes and the primary research methods of the field. (Social Science learning outcome #2) 2. Learn how to complete a political science research project, from articulating a research question and gathering information to analyzing data and presenting results. (Social Science learning outcome #3 and Information Literacy learning outcome #1) 3. Evaluate information and sources critically and decide whether initial question should be revised. (Information Literacy learning outcome #2)
